7. Failure to meet any of the above mentioned regulations will result in a parking ticket from the Madison Police Department. **NO EXCEPTIONS.**
8. Any parking tickets issued will not be rescinded by the management.
9. There will be a \$25.00 charge for replacement of permit tag.

11. Landlord shall not be liable for any damage to automobile or the contents thereof, done or occasioned by theft, vandalism or the action or failure to act, whether negligent or otherwise, of other people.
